DESCRIPTION

In 2015, Audubon embarked on a journey to breathe new life into one of their longstanding assets—the ANI Audubon Aquarium, an undertaking that included the relocation of their existing Insectarium from its previous home in the Customs House on Canal Street and the expansion and renovation of the Aquarium itself—two vital community offerings housed for the first time under one roof. Along with the Insectarium program, the scope included a crystalline–configured entry lobby, a new lobby grand stair and glass bridge, re–envisioning of the existing Mississippi River Gallery into a bayou experience, a refreshed Amazon



Exhibit Gallery, introduction of a new Top-of-Gulf tank experience, two gift shops, and the reversal of the exhibit flow experience throughout the aquarium exhibit spaces. Designed by New Orleans and Washington, DC-based architecture firm EskewDumezRipple, in collaboration with architects and exhibit designers CambridgeSeven (based out of Cambridge, MA), the project is a stunning revitalization of a civic amenity in the heart of New Orleans.

Have a client looking to redevelop a vacant and/or underutilized property in your community? Need help addressing environmental concerns to move the project forward? Attend this session to learn more about resources available through the Brownfield Program! Through EPA's Brownfield Program , the Louisiana Department of Environmental Quality's Targeted Brownfield Assessment Program helps address environmental issues at vacant/underutilized properties to facilitate their reuse. Attend this session to learn about resources you can bring back to your clients to address lead, asbestos, underground storage tanks and other environmental hurdles to redevelopment. We'll go over the environmental process and how it can coordinate with the project timeline as well as ideas for connecting cleanup activities with the design plans and reuse of the site. In addition, we'll touch on technical assistance available for to support the reuse of the site such as market/ economic studies, redevelopment planning, and infrastructure analysis. At this session you'll hear about:

- EPA Brownfield resources for environmental assessments and cleanups and how to access them.
- The importance of a Phase I environmental site assessment for liability protection.
- How to facilitate the environmental assessment and cleanup process for your project.
- Ideas to incorporate environmental cleanup into design and reuse plans to save on time and costs.

This session is especially useful for architects that work on historic preservation projects or on redeveloping existing properties.

What will the future look like? How will potential changes in climate impact your projects and your firm? What policies, plans, and efforts are being undertaken in Louisiana and how will those impact the way design is approached and how interactions with clients and teams are handled? Join our panelists: Greg Grandy from the Coastal Protection Restoration Authority (CPRA), the Louisiana State Climatologist Dr. Barry Keim, and Andreanicia Morris of HousingNOLA who served as a representative on the LSU CCC for the 2021 Energy Code adoption/amendment process about the variety of aspects that will impact Louisiana residents and potential clients, as well as what resources are available to help forecast future design needs of the built environment.



DR. BARRY KEIM
PROFESSOR GEOGRAPHY AND
ANTHROPOLOGY
LOUISIANA STATE UNIVERSITY

BIO

Barry Keim is the Richard J. Russell Louisiana Studies Professor and Chair of the Department of Geography and Anthropology. He also serves as the Louisiana State Climatologist. His research focuses on climatic extremes, with particular focus on heavy rainfall, hurricanes, and storm surge. He is also an expert in matters concerning climatic data and its interpretation. He has published extensively in these areas, and he currently has 87 refereed publications, 2 books, as well as numerous other technical reports. As State Climatologist, Dr. Keim conducts climatic research on the State of Louisiana and the broader region, he serves the community by providing climatic data to those in need (i.e., researchers, government agencies, police departments, etc.), and provides interviews to the media. He also serves as the LSU Director of a NOAA-funded research program called the Southern Climate Impacts Planning Program (SCIPP), which is a joint venture with personnel at the University of Oklahoma. This program is charged with developing stakeholder driven research across the region, which has led to the development of a storm surge database called SURGEDAT, which is now the world's largest and most comprehensive database of global storm surges. He is also director of the Disaster Science and Management at LSU, which is a core piece of the BA and BS programs within Geography.

The 10-year Strategy and Implementation Plan is a comprehensive strategy guided by data and community input to implement policies that make strategic choices to address inequity issues in housing. Morris has spent her career working to create affordable housing since graduating from Loyola University New Orleans. After Hurricane Katrina, she implemented programs that created over 500 first time homebuyers, secured \$104.5 million soft second subsidy for Metro New Orleans and provided supportive services for approximately 5,000 households—homeowners who were struggling to rebuild and renters who required wrap around services.

Morris was lead organizer for the Greater New Orleans Housing Alliance (GNOHA) when it started in 2007 and, since its incorporation in 2012, Morris has served as GNOHA's President. GNOHA's advocacy supported members and partners in developing approximately 88,000 housing opportunities between 2006 and 2015. Gambit Weekly named Morris 2017 New Orleanian of the Year for her role in HousingNOLA's innovative strategy.
