- Must be a resident architect holding a current Louisiana license
- Must live in district in which they are seeking nomination
- We need 5 candidates (one from each district) (see attached)
- Candidate's name due to Kathy by April 1st

- Deadline for Nomination Package Submission: April 1st

Announce at all meetings about the LAF "Patron of Architecture" Award.

- Given to non-architect
- Deadline for Nomination Package Submission: June 1st

Announce at all meetings about the AIA Louisiana Professional Achievement Awards:

- Associates Award: Associate members of AIA Louisiana who are not licensed to practice architecture by the submission deadline are eligible to be nominated. Any component or a member of the AIA Louisiana Board of Directors may nominate one or more individuals.
- Emerging Professionals Award: Architect members of the AIA who are members in good standing and have been licensed to practice architecture fewer than 10 years by the submission deadline are eligible to be nominated. Any component or member of the AIA Louisiana Board of Directors may nominate one or more individuals.

Deadline for Nomination Package Submission: August 3rd

- Identify someone from your chapter/section to serve on the Nominating Committee
- Identify architects in your chapter/section to serve as officers on the AIA Louisiana Board

To submit the name of a prospective nominee for vetting by the Nominating Committee, you should have the following information:

- A brief resume (approx. one page) stating relevant information about the prospect's background and leadership history
- Verify that the person has previous experience on state level committees or leadership.
- President-Elect for 2024 (becomes President in 2025)
