Only AIA Louisiana members may vote. All ballots must be submitted using the **SUBMIT** button below by **midnight, Tuesday, August 27, 2024**. Award entries are located [HERE](#). Please vote by marking an X in the appropriate blanks alongside the number of each project which you feel deserves the Members' Choice Award. Multiple projects may be selected. Please be sure to print your name and member number in the designated areas. Ballots without your name and member number will be discarded.

REMINDER: Do not vote for project(s) submitted by your firm, as your vote will be disqualified.

In order to encourage excellence in architecture, AIA Louisiana conducts an annual Awards program. Through this program, AIA Louisiana seeks to honor works of distinction by its members and bring to public attention outstanding examples of architecture.

AWARDS WHICH MAY BE GIVEN

HONOR AWARD & AWARDS OF MERIT

Awards will be granted to distinguished projects by a jury of architects whose work and reputations have been established at the highest level of the profession. Each project will be judged according to its own merit, not in competition with other entries. Awards will be given at the discretion of the Jury and there is no obligation that the jury present awards for each classification.

ARCHITECTURE - awards shall recognize projects in the categories of New Construction or Renovation.

INTERIOR ARCHITECTURE - awards shall recognize interior architecture/interior design projects of any type including renovations, rehabs, offices, institutions, residences, retail projects, restaurants, single-family homes and public facilities.

MASTER PLANNING/URBAN DESIGN - awards shall recognize projects (either built or un-built) in the field of master planning or urban design.

RESIDENTIAL - awards shall recognize exceptional work by architects in the field of residential architecture.

RESTORATION/REHABILITATION/ADAPTIVE REUSE - awards shall recognize exceptional work by architects in the field of restoration and rehabilitation as distinguished from the work of the original architect (Restoration: An act of restoring or condition of being restored. a bringing back to a **former position or condition**).

UNREALIZED PROJECTS - awards shall recognize un-built architecture and urban design as well as theoretical or conceptual work, including installations, land art, and research. Projects cannot have been undertaken for academic credit.

SMALL PROJECTS – awards shall recognize small projects for the high quality of their work and to promote excellence in small project design. This program strives to raise public awareness of the value and design excellence that architects bring to projects, no matter the limits of size and scope.

MEMBERS' CHOICE AWARD

In addition to the awards granted by the Awards jury, AIA Louisiana shall grant a Members' Choice Award to be selected by the AIA Louisiana members. The project receiving the highest number of votes shall be granted the AIA Louisiana "Members' Choice Award". **This Honor Awards Program Dinner will be held during the AIA Louisiana Conference on Architecture at The Weston New Orleans, New Orleans, LA, on Friday, September 20, 2024 from 7:00 – 8:15 pm (Ticket Required), with a Celebration Cocktail Party immediately following.**

Please do not vote for any project submitted by your firm, as this will disqualify your ballot. *If you were employed by a firm during the period in which that firm was producing a project currently entered into the AIA Louisiana Awards Program, you will, for the purposes of this ballot, be considered on the same basis as current firm employees.*
